**FISCAL IMPACT:** The cost of consolidating the election varies each election cycle, as the County coordinates and consolidates our election, with other agencies; hence the overall cost is greatly reduced. The amount in the 2022/2023 fiscal year budget is \$9,000.

**BACKGROUND:** Attached is a copy of the above referenced resolution that requests the consolidation of the District's Biennial Election with the November 8, 2022 General Election. In order to participate in the County process, the District is required to provide the following documentation to the Office of the County Clerk-Recorder:

1. Notice to County Elections Official - Elective Offices to be Filled
2. A map of the District's boundaries
3. A resolution by the Board of Directors requesting consolidation with the November 8, 2022 Consolidated General Election
